What is included in the exhibitors' fee?

The Exhibitor's fee includes 6-foot table (skirting not included), two chairs per your request form, and one listing in the conference program. Additional advertisement can be placed in conference program for an additional fee. Lunch will also be reserved for up to 2 individuals indicated on Exhibitor Table Request form. Additional lunches will be \$10 each.

How will exhibitor tables be assigned?

Table locations are assigned on a first come, first served basis. To ensure you receive your preferred table location, please submit your request and payment **no later than May 10, 2013** to the Neighborhood Resource Center, P.O. Box 120246, San Antonio, Texas 78212. <u>Your request and table assignment will not be processed until full payment has been received.</u>

Will supplies or electrical outlets be available?

No supplies, copy machines, dollies, are available at the conference. Electrical outlets are limited and will be assigned based on those who request outlets and register first. A "trouble-shooter" volunteer will be available to assist with questions or problems that may occur.

What can we provide at our Exhibitor tables to conference participants?

Information handouts and giveaways are encouraged at exhibitor table.

When are the anticipated best times for exhibit area traffic?

22 tables are located in the main exhibitor area, an additional 6 are available in the General Session area. Several breaks are scheduled between events to facilitate traffic. Best times will be during registration and between workshop events.
