May 2024 Meeting Minutes for Harris Branch Residential Property Owner's Association, Inc.

A. Call Meeting to Order/Establish Quorum. (Vanessa Silas)

- a. Meeting was called to order by the Board President, Vanessa Silas at 6:33 pm. i. Board members in attendance (4 of 5—Quorum established):

B. Meeting-Minutes Approval

Vote passed to approve the April 23rd, 2023 meeting minutes with a unanimous vote Homeowner Forum - President Silas opened the Homeowner Forum.

a. Resident from Stirling Bridge – brought up concerns with Goodwin management, citing specific examples, including: Fine for BBQ in driveway, snakes and pests intruding backyard due to unkept greenbelt behind house. Requested information when contract is up with Goodwin based on issues with communication and rights as homeowner.

b. Resident from Speyside – Houses on being kept up, speed signs/bumps needed. c. Resident from Speyside – Drinking at apartments across from homes on Boyce Lane.

d. Resident from Speyside – Shared concerns with online behavior from Anthony "Mane". D. "Mane" is Anthony Murray a Harris Branch Board Member.

e. Resident from Lakeview South - Requested contact for mailbox issues / damage.

f. Resident from Meadowview – Suggestions to improve subdivision. Sent email to Jackie and copied Vanessa and Anthony. Extend walking trail behind house. Mosquito problem near house, improve drainage for standing water pooling.



g. Resident from Edinburg – Request actions to address snakes in tall grass? Issues by ponds and in Edinburg. Brought up concerns over code of conduct/ ethics contract violations. Issue with homeowners being able to communicate directly with vendors.

C. Treasurers Report - Vinnie Guadiz

a. April 2024 Financial Review.

b. Went over budget on admin expenses by over \$7k. Fence repair and pool/ spamaint/supplies over budget. No budget set for security/monitoring (Ranger), so over

budget every month.

Vote - Vanessa motioned that the April financials be approved. Jose seconded the motion. The vote was called and a unanimous vote approved the April financials.
