#### New Board Member

#### Front Entrance Makeover

We hope you have noticed the front entrance has had a makeover! There have been several positive comments about the change in appearance. We will be taking down the dead trees in the islands just north of the Corporate Woods Bridge in the next few days, so please keep a look out for this work to begin.

#### **Volunteer Opportunity**

#### **Proper Property Reports**

As a board member I encourage members to report property issues, but please be as precise as possible and avoid exaggerating the issue. For example, don't report that gutters are falling off a house when they simply need to be cleaned. We take each report seriously and generally follow up the same day to take photos and pass them on to KYSE. When someone exaggerates an issue and we find something less pressing, we tend to dismiss the complaint. So please don't cry wolf unless there is indeed a wolf to deal with.

#### Take Pride In Your Property

We say this a lot, and it bears repeating because it's so important: we should all take pride in our community. A sense of community and civic pride includes taking care of your property. By far the most consuming job for any board is dealing with compliance issues where homeowners or those renting the property fail to keep up the property. This issue alone costs our HOA membership money that could better be spent on other needs and improvements. If you see your neighbor attempting to cut a driveway through their front yard to the back, you should know that is forbidden by the covenants.

Currently, we have two pressing issues involving two homes failing to take care of their roofs and another surreptitiously trying to install a driveway around their house. Each of these issues involves a great deal of time and effort and even legal work to stop and correct the issues.

#### <u>Updates</u>

We will be staining the fencing along Corporate Woods in the weeks ahead. This is the new fencing we installed last summer. The covenants state that common fencing (RWHOA owned and maintained) must be stained to show the natural grain of the wood.

DECLARATION OF PROTECTIVE COVENANTS REDLAND WOODS SUBDIVISION Article 12, paragraph 12 clearly states, "..., all fences and gates facing a public street or roadway shall be constructed of masonry, wrought iron or vertical, solid cedar or spruce. All wood fences and gates shall be left natural, covered with a natural clear stain or covered with a clear wood preserver..."




